**Subject – Circular for Classes I to X for Rubella Vaccination Drive**

Dear Parents,

Ministry of Health & Family Welfare has launched & phased nationwide campaign to support WHO's campaign to "Eliminate Measles & control Congenital Rubella Syndrome (CRS) by 2020.

This vaccine will be given in all schools including government, private, missionary, Kendriya Vidyalaya, etc. for children in the age group of 9 months to 15 years.

Officials from Health Department of Pune Municipal Corporation will conduct **vaccination drive in The Orchid School on 19<sup>th</sup> December 2018.**

Please note the important points related to vaccination:

1. The vaccination drive will be conducted during the school hours.
2. The vaccine will be given to all students from Classes I to X irrespective of age.
3. Parents have to fill the consent form attached in the circular before the vaccination takes place.
4. Vaccination will be given to student only after receiving the print copy of Consent Form from parents.
5. There are some precautions that needs to be taken before the vaccine is administered that are mentioned below-
  - a. The vaccine has to be taken on full stomach.
  - b. Student with the history of convulsions should not take this vaccine. In this case the details need to be provided by the parents.
  - c. New syringe will be used for each child.
  - d. Trained Doctors and Nurses from Pune Municipal Corporation will administer vaccination drive.
  - e. If parent wish to attend vaccination, they are most welcome. The schedule of vaccination will be shared before the date.
  - f. There will be an **orientation and interaction session** with parents conducted by the Health Department Officials on Saturday, **8<sup>th</sup> December 2018 at 11:15 am**. Parents are requested to attend this session to update themselves with the information and at the same time can ask the questions / clarify their concerns.
