The School had to suspend all operations all of sudden due to the lockdown imposed to inhibit the spread of the Corona Epidemic, with effect from 15<sup>th</sup> March, 2020, as per directions of Government of India and still operations are under suspension. As per directive of Zillha Parishad previous year's (Academic Year 2019-20) PTA can be continued for the Academic Year 2020-21.

Staff may have to stretch beyond working hours. To open the school physically school needs to invest in the sanitization equipment and materials. The overall operational cost for school will increase. The recommendation by the government is that salary should be paid to all the teachers, no teacher to be terminated.

# Fee Proposal Academic year 2021-22 based on GR

The proposal of fee structure for the AY 2020-21 in revised form was shared with the members. As per the proposal the 8% fee hike that was ratified by the PTA members in the month of Novemeber'19, will be rolled back.
