- The 2nd instalment fee details are updated in the fee portal.
- Last date for fee payment of 2nd instalment is Monday, 17th July 2023.

Some important points to note:

- School will accept online fee payment only via Edunext Fee Portal. Please click on the link https://tos.edunexttechnologies.com/Index . The fee link will be operational from 4th July 2023.
- Shared the circular TOS/FRO/CIR/FS/23-24/6 dated 03.07.2023 to follow the steps to pay the fee payment.

- The school will arrange a bank counter in the school premises for parents who wish to opt for physical payment.
- Accounts Office in school will not accept direct cash payment for fees.
- > Do not pay the school fees via UPI, NEFT as it is difficult to track the payer in case parent forgets to mention the name of the ward.
- In case NEFT/UPI etc. mode of payment done and is not identified then in that case the late fee will be applicable beyond the due date.

Net Banking, Credit Card and Debit Card. However, there are different charges levied by each bank for these transactions. Below mentioned is an indicative table highlighting the charges.

- All instalments are based on the academic cycle of the respective grade.
- All camps, excursions etc will be charged over and above the fees. The communication of which will be shared subject to Covid norms in terms of field trips and camps.
- Parents have an option to pay the entire fee for the AY 2023-24. This will help in possibility
 of parents to not miss any instalment.
- Please note the due date for monthly instalment will be the 20th of the respective month.
- The school charges a late fee of Rs 50 per day for fees paid after due date.
- This late fee will be applicable for monthly as well as quarterly instalment. Late fee will be charged for each pending instalment and not on the total fee due.

Please note the school has been reaching out to parents for payment of pending fees via weekly SMS, emails and phone calls regularly. We hope you understand that payment of fees for your ward is your responsibility and we do find it difficult to continue providing learning facilitation in case of non-payment of fees.
