PNES has made an initial payment of **4 Cr.** Hence the matters are resolved between both parties and as a result the school will continue to use all the spaces including basement, terrace and auditorium.

1	Legal Issues with the Bank	<ul> <li>Namrata Di welcomed the parents and Mr. Vilas Patil and shared the agenda and the purpose of the meeting.</li> <li>She gave a brief context of this meeting and invited Mr. Vilas Patil to address the parents.</li> <li>Mr. Vilas Patil welcomed all the parents .He informed the parents that PNES, the board which runs The Orchid School has acquired the basement, Auditorium and 5<sup>th</sup> Floor on rent from VVDPL, the original owners of this land.</li> <li>VVDPL unfortunately had mortgaged these specific properties to the Thane Bharat Sahakari Bank.</li> <li>Due to default of payment, the bank has sealed these locations after warning to the defaulters.</li> <li>However, as the notification was not directly shared with PNES, the board was not aware of the sudden sealing of the property.</li> <li>PNES has currently appealed in the High court and based on their directives the case is underway in the Debt Recovery Tribunal.</li> <li>On24th January 2025, the board will pay the bank the said amount and acquire all these spaces.</li> <li>However, as these are legal matters, the same may take time till end of February 2025 to have a final closure.</li> <li>He assured the parents that the school was financially extremely sound, and the board was actively looking into this issue.</li> </ul>
2	Parents queries	<ul> <li>Few parents enquired about the duration of the case and showed their concern with the fact that the school students were being inconvenienced due to this legal case.</li> <li>Few parents also enquired about the consecutive annual fee hike of 12% as they were worried that this trend of fee increase would not be</li> </ul>

		<ul> <li>Parents enquired as to what was the amount still recoverable from government for RTE students.</li> <li>Parents shared that the deficit of income from RTE should not be a deciding factor for earmarking the fees for the other students.</li> <li>Namrata Di mentioned that during Covid since 2020 the school had not increased the fees as per its usual percentage. Hence, the current fee hike may seem high, however averaging it would ensure that the school has not abruptly increased the fee.</li> <li>A few parents requested the management to send an email to all parents justifying the fee hike and sending them an assurance for a reasonable increase next academic year. This would instill a sense of confidence amongst the parent community.</li> <li>Namrata di shared that the PTA Minutes are put on website as a practice after every meeting.</li> </ul>
